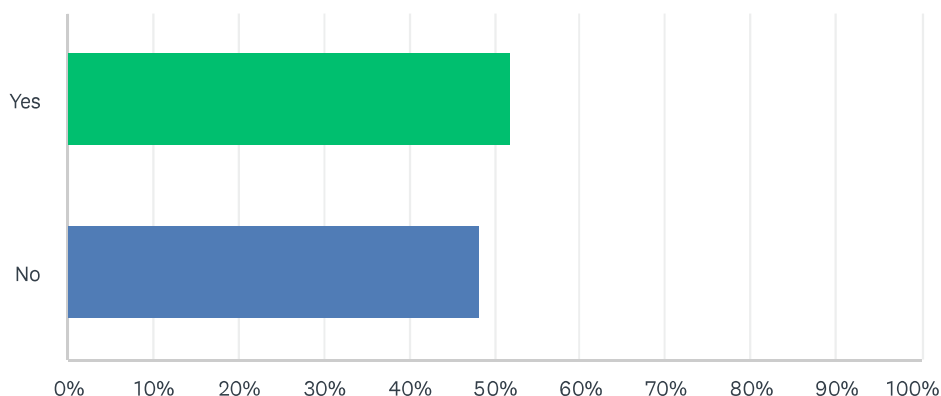


Q1 Over the past two years, has your business been negatively affected by any disruptive or criminal behaviors from individuals whom you believe are homeless?

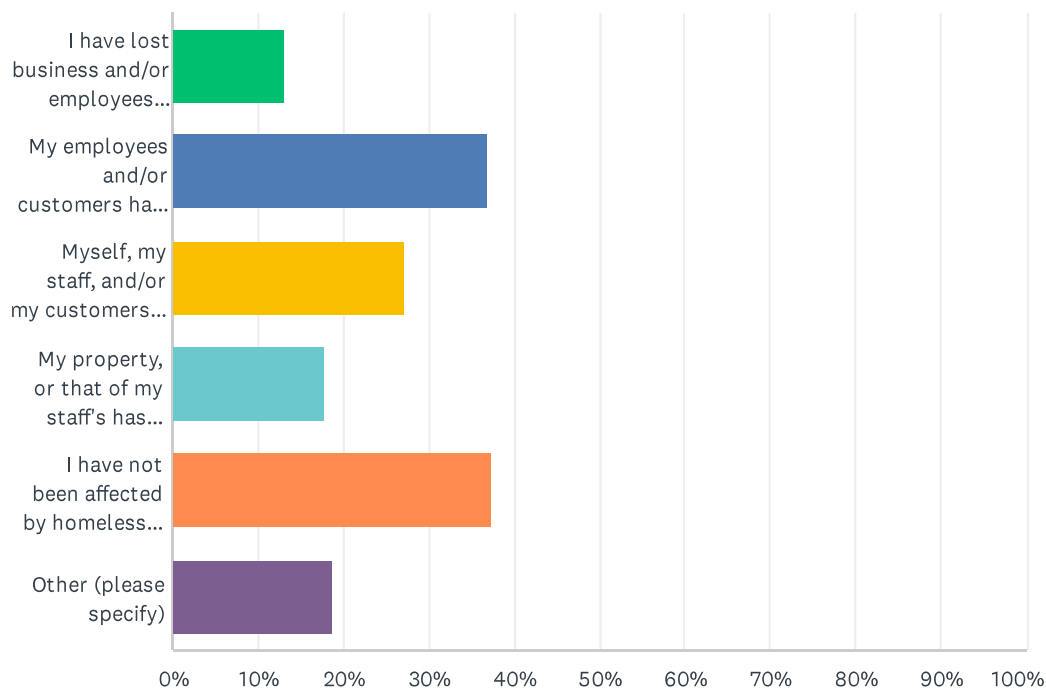

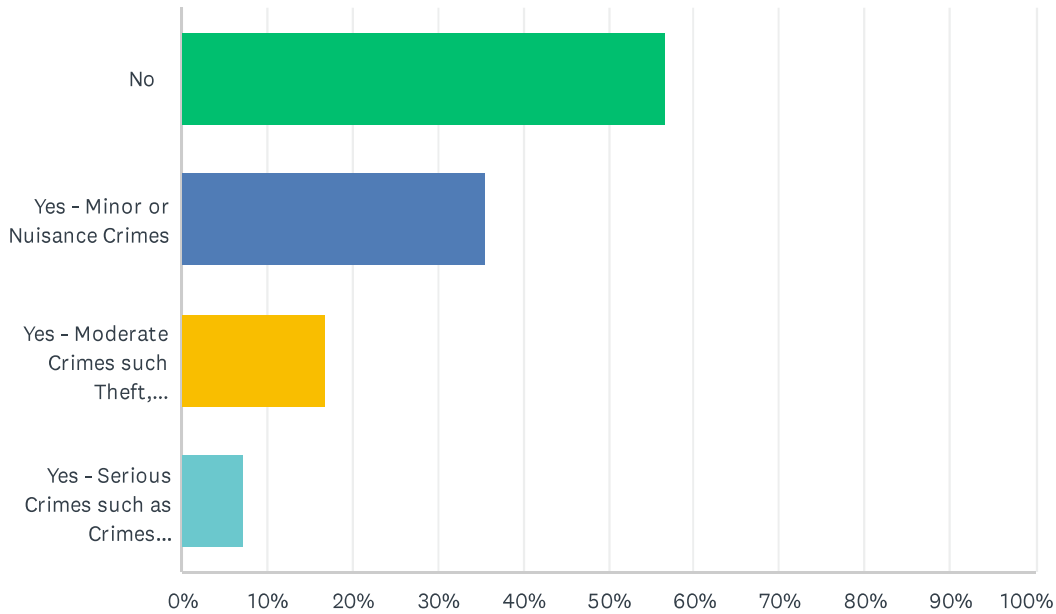

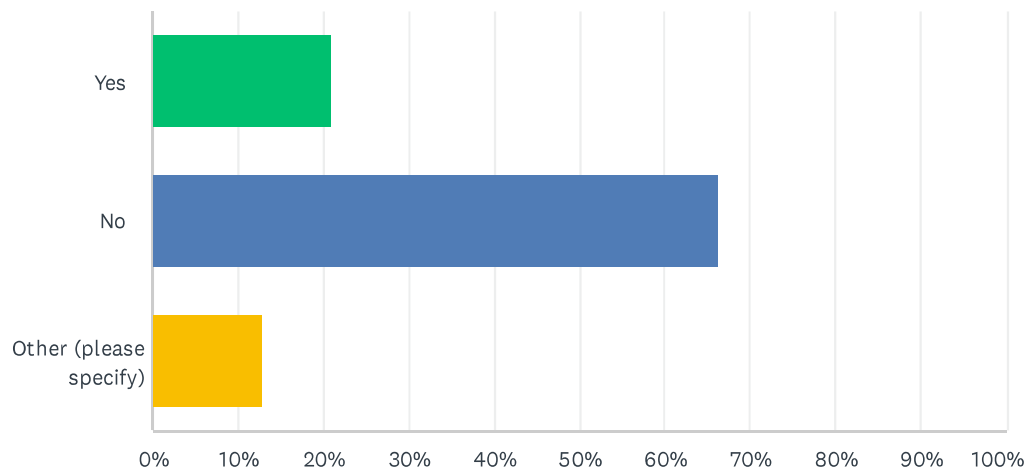
